Applicant agrees that Roofing Wholesale assumes no liability for late or non-delivery of materials ordered. Any claim Applicant may have against Roofing Wholesale Co., Inc. must be presented in writing within 30 days of the occurrence of said act causing the claim or said claim is waived. In the event Applicant wishes to make a claim upon Roofing Wholesale Co., Inc. for defective material, said claim must be made in writing within 30 days of the receipt of the merchandise or said claim is waived. Applicant agrees that any legal action commenced or maintained by either of the parties shall be brought in the Maricopa County Superior Court, Maricopa County, Arizona.
