In the event Applicant wishes to make a claim upon RWC Building Products for defective material, said claim must be made in writing within 30 days of the receipt of the merchandise or said claim is waived. Applicant agrees that any legal action commenced or maintained by either of the parties shall be brought in the Maricopa County Superior Court, Maricopa County Arizona.
